<u>Working Group Members</u>: Dan Bradley, Kathleen Ryan and Parking Team <u>Working Group Purpose</u>: review proposals; create short list of recommendations to PAC Other Notes to Consider:

- -Will be creative in how we could gather data for RFP
- -Concurrently meet with interested private parking owners interested (who have great data!)
- -If we provide data, CODE FOR BTV will analyze it for us for free
- -Amtrak will be present in BTV; how to best accommodate anticipated parking in future (Meet with Melinda Moulton?)

c. Faith Based

(Nate Wildfire)

Outcomes:

- 1. All groups (6-7 represented) do different things with parking; overall lack of communication. Example: Unitarian Church leases out spaces to office workers.
- 2. All groups interested in playing a role to better manage parking in Burlington.
- 3. Churches will act as a liaison to its attendees so that they can:
 - -weigh in
 - -influence change
 - -gain insight/education
- *Will try same tactic with Burlington cultural institutions (i.e. Flynn)

Other Notes:

- -Intent on keeping parking free until noon on Sundays (to retain church attendees).
- -Alternative: "code" for churchgoers to type into multi-space meters (great way to collect data!)
- -Parking Team made aware "2 hr free" also helps target group who need access to services

e. DPW Commission Ordinance Revisions (Chapin Spencer)

The following ordinance revisions were passed unanimously:

- -Street meters to accept other forms of payment (in addition to coinage)
- -Recognition of meter or multi-space meters

III. PILOT PROJECTS*

<u>Meeting Goal</u>: to get input/feedback on *rough draft* of proposed pilot projects (all city pilots) Overall Goal of Pilot Projects:

- -Educate
- -Get feedback from users
- -Collect data

Plan of Action:

- -Pilots will jumpstart Downtown Parking Initiative
- -Pilots will provide data (on-street parking) to give to RFP firm
- -Try out changes concurrently

Other Pilot Project Concerns:

Q: Would it be better to try out a less pilot projects for a longer duration of time?

A: More pilots=better. For instance, the Easy Park might be better for delivery trucks and contractors, but not be useful for out-of-towners (whereas pay by cell phone would). Gathering data allows us to see all possibilities.

Q/A: When implementing pilots, it is necessary to make clear that the temporary changes are being made with the intent to maximize *existing* parking resources.

Q: When we charge for parking after 6 pm, will we deter workers (i.e. restaurant folks) from wanting to work in Burlington?

A: Something to think about. Also: on-street parking will be free after 6 pm (just not garages).

IV. Downtown Parking Initiative Logo Concepts

Meeting Goal: initial feedback

- -Select Design has been working with Kelly to put together some parking logo concepts
- -Will be posted in Google Drive for review
- + Green, Blue, White colors
- +Like integration of universal parking symbol (P)

V. City Council: Action Regarding Parking Minimums

History

- -Planning Department spent 2013 working to forward recommendation to eliminate parking minimums for new development (and eliminate parking minimum zoning requirements for existing buildings). It is a recommendation out of PlanBTV.
- -Also the strongest recommendation from visiting parking experts during Parking Summit/Convening in November.
- -Planning Commission: passed unanimously
- -Ordinance Committee: passed 2:1
- -City Council: Did not pass. Here's the reasoning:
 - 1. If developers build ZERO parking the rest of BTV's parking system would become exasperated (could spill into residential parking).
 - 2. This ordinance becomes a dichotomy of developers versus everyone else Option: developers pay a certain amt of \$ if not required to build a certain # of spaces







City Council's Proposed Next Steps:

- 1. Planning Commission to regroup and consider an amendment to eliminate parking minimums for existing structures.
- 2. New development: evaluate to see if it makes sense to add an impact fee.
